Murunga project was moved by the NTI in 2023. Initially 100 saplings and 100 stems were distributed more than one year ago. It is now ready for producing yield. NTI will continue to promote supplying seedlings. Murunga augments immune system due to High contents of vitamin C and antioxidants. It helps to combat against common cold, flu and remove off several common infections. The anti-inflammatory and anti-bacterial properties of Murunga assist in lessening the symptoms of asthma, cough, wheezing and other respiratory problems. So far 200 families have been provided with seeds, seedlings and stems.NTI supported project is being continued with.
